n promoting Buy Kenya Build Kenya initiative, the Cabinet Secretary noted that the Government is working towards 100% access into the domestic market by the EPZ pharmaceutical companies.

Other EPZ pharmaceutical companies are Dinlas Pharma EPZ Limited, in Machakos County manufacturing tablets, capsules, syrups and ointments. Ivee Aqua EPZ Limited within Athi River EPZ manufacturing eye, ear and nose drops and infusion fluids while Revital Healthcare EPZ Limited in Takaungu, Kilifi County manufactures plastic medical disposals - syringes, infusion and blood transfusion collection tubes.

In January 2018, Bangladesh - based Square Pharmaceuticals broke ground within Athi River EPZ where it announced plans to set up its first plant in Africa to manufacture tablets/capsules and liquid medicine.

Hon. Tarek led a German business delegation to EPZ Athi River as part of their mission to explore possible investment opportunities in Kenya.

B. Braun EPZ Pharmaceuticals Limited is the first German investment in the EPZ Program; following H. E. President Uhuru Kenyatta's visit to Germany in April 2016 and further adds to the growing list of pharmaceutical firms operating in the EPZ program.

There are 150 German companies in Kenya, including B. Braun Pharmaceuticals, who employ about 5,000 people.



# **Export Processing Zone Program - a regional tool for development**

Through the realization of the Msambweni multi-sectoral EPZ industrial park; the first of its kind to be undertaken in Kwale County, the project is expected to spur rapid socio-economic development in the coastal region by creating opportunities for harnessing natural resources.

It will also be one of the platforms through which the Blue Economy can be exploited.

PZ Authority is seeking to develop and establish additional and new zones countrywide to replicate the economic development impacts that the EPZ program has had in the regions they are already situated in.

Counties where public zones are earmarked for development are Kiambu, Meru and Kisumu; who have expressed great interest in the EPZ program by setting aside land to develop EPZs

Areas identified for the establishment of private zones are: Nakuru, Kiambu, Muranga, Kwale, Narok and Laikipia.

There are 72 existing zones situated in 19 counties hosting a total of 136 EPZ firms engaged in a variety of operational activities namely; food/agro-processing, beverages/spirits, chemicals, commercial & commercial craft and leather, dart-boards, electrical/electronics, garments and garment support services, minerals/gemstones, pharmaceuticals and medical supplies, plastics, printing, relief supplies, services and other activities; joinery works, leather and silicone products.

The EPZ program remains a tool for regional development, job creation and the general development and growth of the area surrounding the zones in their respective geographic locations once the necessary industrial infrastructure; power, water, sewerage, and telecommunications is put in place.

### Increased investment in extraction of natural oils in the EPZ
